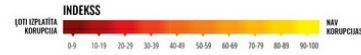

Corruption Perception Index 2020: Latvia shows little improvement from last year, needs to take serious steps going forward

Transparency International, the global anti-corruption organization, has published the results of its Corruption Perception Index 2020.

Latvia's score, compared to 2019, has increased by 1 point, reaching a score of 57, putting it in 42nd place equal with Cyprus and Costa Rica. While the increase can be viewed as a step in the right direction, Latvia's CPI score has stagnated over the past several years and remains behind many EU and OECD nations.

Latvia's Parliament (Saeima) Asked for Public Comments on Proposed Law Regulating Openness in Lobbying

Corruption Prevention on January 26 presented for public discussion proposals to regulate transparency in interest representation and lobbying. Public comments on the proposals and future actions continued till February 26. The Commission hopes to obtain the views of interested parties on the proposed legislation. The comments and recommendations will be made public on Delna's homepage on lobbying.

A Step Closer to Eliminating International

The US has approved the National Defense Authorization Act for Fiscal Year 2021 that includes the Anti-Money Laundering Act which

Fiscal Year 2021 that includes the Anti-Money Laundering Act which will help combat international money laundering. The legislation requires all companies that operate in the USA to disclose their beneficial ownership [to the US Treasury Department at the time of incorporation], a provision which will allow Latvia's legal institutions to better investigate international money laundering schemes involving Latvia.
