

#### **Discussion on Trust to Public Institutions**

Transparency Internationa Latvia (TI Latvia / Delna) and the US Embassy in Latvia organized international online expert forum and roundtable discussion: "How to Promote Trust in Public Institutions in Latvia". This event was the third expert forum and roundtable in a series of four events dedicated to the recommendations of the Council of Europe's Group of States against Corruption (GRECO) and to Latvia's progress in preventing corruption and promoting transparency.

The aim of this event is to raise awareness and understanding of society's trust in public institutions, the factors that influence this trust and ways to increase it. The lack of trust, especially in government institutions, makes finding and implementing solutions to our communities' greatest challenges – like national security, economic growth, and COVID-19 responses— even harder.

### Delna Publishes a Study on Money Laundering in the Baltic States

Delna has published its latest study on money laundering in the Baltic States, identifying the main features of complex money laundering schemes conducted through Latvian and other Baltic banks. In the study, we assess the efforts of these governments to prevent the recurrence of similar schemes in the future.

Based on the study, Delna makes recommendations to the Latvian government, pointing to the need to support current EU efforts to establish a supranational monitoring and reporting mechanism for cross-border transactions, as well as indicating a number of other practical measures. # Global Anti-Corruption Barometer 2020: the Government's Fight Against Corruption is Inadequate

This year, the international anti-corruption organization Transparency International (TI) published the results of the Global Corruption Barometer (GCP), revealing the perception of corruption in the European Union (EU), also in Latvia. Although the situation has improved over previous years, the people of the EU and Latvia still have gloomy views. The COVID-19 emergency has also had a negative effect on their perceptions.

To explain the implications of the results of the GCP 2020 as well as perceptions of public corruption in Latvia, Delna:

#### **Training: "Opposite of Patriotism"**

In August, Delna participated in the training of national defence training instructors. Delna director Inese Tauriņa led classes for about 130 instructors on corruption, its negative consequences, recognition, etc.

National defence training is included in the national secondary education standards as a compulsory subject starting from 2024. As of September 2020, with the introduction of a competency-based curriculum, approximately 1900 secondary school students are taking a specialised course in national defence training in the field of health, safety and physical activity.

### Delna Discussions at the Conversation Festival "LAMPA"

On August 20 and 21, 2021, Delna invited everyone to Latvian town Cēsis, where the conversation festival "LAMPA" took place. On the Delna's stage "Kā uz Delnas" we talked for two days on the topics of transparency, public participation and anti-corruption in total we organized 7 discussions:

- How I can participate in the decision-making in my school and municipality?
- What has the 13th Saeima (Latvian Parliament) done to reduce corruption? What are the next steps?
- · Is my municipality transparent?
- Why a company should be transparent?
- Why to blow a whistle in the workplace?
- Cryptocurrencies and money laundering. How to prevent these crimes?
- Is there corruption in Latvia? Opinion of the population.

#### Delna's Researcher: The Covid-19 Pandemic has Revealed Long-term Vulnerabilities in Latvian **Democracy**

In July, Delna published a report on the impact of the measures taken during the Covid-19 pandemic on the level of openness in Latvia. The report was based on Covid-19 crisis trends identified by TI and on focus group discussions.

According to Delna researcher Olafs Grigus, the report finds a concentration of power at the government level, with the Saeima relinquishing its functions in favour of faster decision-making. It has been concluded that the Saeima generally does not monitor what the government's propositions during the crisis.
